## MSA NATIONAL CIRCUIT MOTORCYCLE CIRCULAR 2 OF 2017

Following on from the recent Circuit Motorcycle Commission meeting the following clarification is made with immediate effect.

As per the provisions of GCR 121 (ix), attendance at riders' briefings is compulsory for all riders at all events. Attendance at such briefings is limited to riders, the parents of minor riders and entrants (where other than the rider). Failure to attend riders' briefing, without being excused by the clerk of the course, shall render offenders liable for disciplinary action to be taken against them as envisaged in the National Circuit Motorcycle regulations SR 11 j.

### Further Competitors are reminded of the provisions of rule 12.45 k

12.45 k Protective race helmets MUST BE Snell, Dot, JIS or ECE Approved and must be double D ring.

### Competitors attention is drawn to Circuit racing SSR Circular 1 of 2017

#### 41. STOPPING OF RACES

##### (i) MOTORCYCLES

For all motorcycle circuit racing (regardless of event status), race officials are hereby advised that they are required to **immediately red flag** a race in circumstances where a rider and/or a crashed motorcycle is lying anywhere on the track surface or in what would reasonably be considered to be a dangerous position off the track surface (for example, in the run off area on the outside of a high speed corner).

### The following amendment is made to rule 12.4 (d)

- (d) Triple digit numbers will only be approved on the express written authority of the Technical Consultant.
