MSA MOTOCROSS NATIONAL CIRCULAR 03 OF 2019

Please kindly note below amendments to the MSA South African National Motocross Standing Supplementary Regulations:

243. CLASSES AND ELIGIBILITY OF MOTORCYCLES AND RIDERS (to be read in conjunction with SSR 242 (ii)).

- i) MX 50cc 2 stroke (Water cooled motorcycles not exceeding 52cc)
Age – Open to riders from the year of their 4th birthday, to 31 December of the year in which their 9th birthday occurs.
Please note that the age for female competitors will be from the year of their 4th birthday, to 31 December of the year in which their 10th birthday occurs.
Carburettor size – 19mm as per the **motorcycle** manufacturers specifications (**stock**)
Wheel size - Rear 10" and Front 12"
- ii) MX 65cc (Clutch Lever with gears – motorcycles not exceeding 65cc)
Age – Open to riders from the year of their 7th birthday to 31 December of the year in which their 12th birthday occurs.
Please note that the age for female competitors will be from the year of their 7th birthday, to 31 December of the year in which their 13th birthday occurs.
Wheel size – Rear 12" and Front 14"
- iii) MX 85cc Junior (Clutch Lever with gears – motorcycles not exceeding 85cc)
Age – Open to riders from the year of their 8th birthday to the 31 December of the year in which their 13th birthday occurs.
Please note that the age for female competitors will be from the year of their 8th birthday, to 31 December of the year in which their 14th birthday occurs.
Wheel size – Rear 14" and Front 17"
Will be bore and stroke to capacity only and no further restrictions will apply.
