MSA NATIONAL VW FALKEN POLO CUP CIRCULAR 4 OF 2019

The following amendments to the National VW Polo Cup Regulations are made with immediate effect:

FRONT WINDSCREEN NAME & NUMBERS:

As per the below picture, the size of Names and Numbers are for the new layouts.

Vinyl: Contravision White (Name) Orange (Numbers)

Placement: Name goes just below the "Falken" strip, and the Number below the Name.

The first set will be supplied by VWM, and going forward to be made and supplied by the teams.



28. TYRES – WET WEATHER

The only wet weather tyre allowed is the Falken 215/45R17 87W, Azenis RT615K+
The minimum tyre tread depth allowed will be 1mm across the width of the tread.
This is 75% wear allowed from a new tyre (4mm).

The following amendments are made to the driver conduct regulations:

15. DRIVER CONDUCT

- e) ii) Mirrors: Should a competitor's mirror be folded in the onus is on him/her to take extra care when involved in overtaking manoeuvres. Restricted vision due a mirror being folded in shall not be a valid excuse for contact between cars. Competitors with folded mirrors should exercise extra care and leave sufficient space when cornering to avoid contact.

J) The Process for Reviewing Incidents and Applying Penalties

iii) The COC may issue any penalty at his discretion:

Examples of penalties, but not limited to:

- Observation,
- Receiving a warning,
- Position penalty,
- A time penalty
- Grid penalties for the next race / race meeting.
- Exclusion
- Yellow / Red Cards

iv) Should a competitor fail to attend a hearing, having been called by the COC to attend, and he/she has not excused himself from the hearing, the hearing may continue without the relevant competitor being present.

v) No card (either yellow or red) shall be issued without the competitor being afforded a hearing by the Clerk of the Course. (Except as per 15J, iv.)
