NORTHERN REGIONS CROSS COUNTRY CAR CIRCULAR 54 OF 2018

1. Please note the following additions/amendments to circular 8 of the **REGULATIONS AND SPECIFICATIONS FOR THE 2018 NORTHERN REGIONS CROSS COUNTRY CAR RACING CHAMPIONSHIP**

(1) Please refer to **3. ELIGIBILITY OF VEHICLES** Amend

- a. **Special Vehicles** All vehicles competing in classes B and P must conform to the specifications as set out in the ~~MSA Non-Circuit Handbook~~ 2018 SACCS Standing Supplementary Regulations. **Induction air restrictors as per the 2018 SACCS Standing Supplementary Regulations rule 3.2 will only apply to Class P. No induction air restrictor necessary for Class B for the regional championship series.**
- b. **Production Vehicles** All vehicles competing in classes D and E must conform to the specifications as set out in the ~~MSA Non-Circuit Handbook~~ 2018 SACCS Standing Supplementary Regulations. **Induction air restrictors as per the 2018 SACCS Standing Supplementary Regulations rule 3.2 will not apply to Classes D and E for the regional championship series.**
- c. **Club Class Z**
The specifications for the Club class will be the same as above with the exception of engine capacity *and/or make of manufacture* which will be unrestricted. **Induction air restrictors is not compulsory.**
- d. **Class X (Cross-Challenge)**
Induction air restrictors as per the 2018 SACCS Standing Supplementary Regulations rule 3.2 will not apply for the regional championship series.
