Circular 1 of ASA 2017 - ASA CROSS COUNTRY SQUAD 2017

With only 76 days to go before the IAAF World Cross Country Championships that will be taking place in Kampala, Uganda on the 26th March 2017.

ASA has selected a strong Cross Country Squad of 24 Junior athlete (12 Junior Men /12 Junior Women) and 26 Senior athletes (12 Women / 14 Men). Both Men and Women senior squads are a mixture of the athletes that participated in the 10km race and the 4km race during the 2016 National Cross County Championship that was held in George, with two junior athletes from 2016 National Cross County Championships namely: Ikageng Gaorekwe and Kabelo Melamu were included in the senior men squad to give them the opportunity to develop into senior level.

ASA will not host Cross County Trials for 2017, however the athletes will be given an opportunity to proof their fitness for selection during the following competitions;

- The Johnson Crane Hire 10km event in CGA (29 January 2016 in Benoni)
- CGA League Meeting 5000m for the 6km Junior Women (21st of January in Germiston at 15:45)

It is compulsory for the athletes that are included in the squads to participate in the above mentioned events in order to be selected for the final team that will be competing at the CAA Southern Region Cross Country Championships (TBC) and the IAAF World Cross Country Championships.

With the edition of the mixed Relay in 2017 World Cross country, ASA will be selecting a team to represent the country.

Athletes not listed in the Cross Country Squad listed below, have the right to appeal for reconsideration in writing, to ASA for att. Hezekiel Sepeng on Hezekiel@athleticssa.co.za before close of business on 20 January 2017. The appeal should include the performance of the athlete, and the date/event of the achievement or the reason for not participating at the Cross Country Championships. Athletes without an ASA Permanent License cannot appeal.

Special Notice: It is recommended that Athletes selected in the Cross Country Squad should obtain a South African Passport and Yellow fever Injections
