Dear ASA Members

Circular 7 of ASA 2017 (01/24) – 2017 FIXTURES, PUBLIC LIABILITY INSURANCE

All 2017 Provincial Fixtures has been listed on the ASA Website since October 2016. The ASA Office has requested for an update of the 2017 Provincial Fixtures, and the ASA Website was updated accordingly.

Your attention is drawn to the 2017 ASA Domestic Rules and Regulations with specific reference to ASA Rule 11.5 (Medical Insurance and public liability for all events on the National and Provincial Fixtures lists for the following year will be negotiated in October of the preceding year).

It is understood that all ASA Provinces and Associates adhere to the clause mentioned above. ASA cannot be held accountable for related claims where Members failed to apply the mentioned ASA Domestic Rule.

With regards to the 2017 ASA Fixtures List; ASA has finalized the ASA Fixtures in October 2016.

Members are reminded that Inter-Provincial Competitions should be listed on the ASA Fixtures List, and should form part of the protection ASA provide to the mentioned events.

ASA annually renew its Public Liability Insurance in January effective in February of the relevant year. The insurance cover the event, as well as the Competition Director and his/her LOC.

In January 2017 ASA provided the Members with more detailed 2017 Fixtures List, which include among other, the Names and contact details of Competition Directors of events listed on the ASA Fixtures List.

As from 1 February 2017 the new ASA Public Liability Insurance will come to effect, to protect ASA events and the LOC's organizing the events.

Likewise all ASA Office Bearers e.g. ASA Board, ASA Commissions and ASA Committees are protected by the mentioned Insurance.

Please note that any event not added to the ASA or Provincial Fixtures, will not be protected, and the relevant Competition Directors should be informed accordingly. (See ASA Rule 11.6). Failure to do so may deem the relevant Member liable for Public Liability Claims resulting from the mentioned event(s).
