

"Integrating Climate Change in EIA" - Tuesday, 10 February 2015

Dear IAIAsa Members and Other Interested Parties

The IAIAsa Western Cape Branch is hosting an event on "Integrating Climate Change in EIA".

Climate change is a measurable and scientifically proven reality, and poses dramatic and irreversible risks for human and natural systems, as well as economic development. Proposed developments could have impacts on climate change through greenhouse gas emissions, but could also be vulnerable to the potential effects of climate change. Environmental impact assessment (EIA) is an important tool to support informed decisions regarding climate change mitigation and adaptation.

During this event, **Prof Nick King**, an extra-ordinary professor at the North West University, will provide an overview of the Intergovernmental Panel on Climate Change (IPCC) Fifth Assessment Report. The report presents projections of future global climate change based on different scenarios and the possible risks that climate change poses, as well as the implications of response options. **Steve Nichols**, Programme Leader: Climate Change and Water at the National Business Initiative (NBI), will unpack and discuss emission reduction measures planned by the South African government. These include mandatory reporting, carbon tax and Desired Emission Reduction Outcomes (DEROs). **Mari de Villiers**, Director of Integro Carbon Consulting, will look at the types of EIA projects which typically require climate change assessment and how such assessments should be undertaken. She will also provide an overview of the lessons South Africa can learn from international experiences on integrating climate change in EIA. The event will then be opened up for discussion and sharing of learning experiences and questions amongst the attendees.
