EVENT VENUE:

ESKOM, Eskom Road, Brackenfell

GPS CO-ORDINATES: -33.53'17.74" **S**, 18.41'06.59" **E**

GETTING THERE: From Cape Town

Take the N1 northbound towards Paarl, then take Old Oak Road / Brackenfell off-ramp. Turn right at the robots. Turn left at the first set of robots (into Frans Conradie). Drive a long way (under bridge) until you see a big grey building in the distance in front of you (the Hypermarket) and yellow town houses on your right. Turn right at four way robots. Go straight over the next set of robots, over the bridge and on your right will be a big complex with face brick buildings. Turn right at the next road and

drive straight into Eskom.

From Airport

Take the N2 towards Somerset West. Take the R300 Bellville turnoff. Take the Brackenfell / Bellville East turnoff (R101). Turn right at the robots into Paarl Road, and past Shoprite on your right. Turn right at the third set of robots, go over the bridge and on your right will be a big complex with face

brick buildings. Turn right at the next road you've arrived!

PARKING: Parking is available at the venue.
