Carbon Tax is a very relevant topic given the promulgation of three carbon regulations last year and the recent publication of the Climate Change Bill for public comment. The Carbon Tax is an element of the mix of measures that governmental departments, including DEA and National Treasury, inevitably are looking to implement in order to achieve carbon emissions reductions that South Africa committed to when ratifying the Paris Agreement end 2016.

Since the implementation of the carbon tax (currently envisaged to happen beginning 2019) has a direct impact on businesses' cash flow it naturally implies a pending risk. But climate-related issues also imply reputational risk as well as compliance risk. The draft bill stipulates measures or situations in which allowances are applicable which could help reduce (or actually better phrased "manage") the financial risk that the carbon tax imposes upon companies.
