Dear AGN Members,

The 2025 AGN Track & Field League 1 will be take place on Saturday, 18 January 2025 at Pilditch Athletics Stadium. The AGN Track & Field League 1 Meeting will be for the age groups U16, U18, U20 and Seniors. Masters and Para athletes may also compete.

The compulsory AGN U16, U18, U20 and Seniors Track & Field Championships that will be taking place on 14 – 15 March 2025 at Pilditch Stadium.

The ASA Age Groups Championships + U23 and Relays + Multi Events are scheduled to take at Green Point Stadium, Cape Town from 27 – 30 March 2025 and the ASA Senior Track & Field National Championships and Multi Events + Relays at the NMU Mc ARTHUR Stadium, Potchefstroom from 24 – 27 April 2025.

Simply inform the teller that you would like to purchase an athlete's entry for the AGN Track & Field League 1.

- Your personal information will be captured by the in-store cashier on behalf of Webtickets.
- Once payment has been made, tickets will be issued by the PnP cashier on your till slip
- You will also receive an automatic confirmation via email and SMS with a link to access your tickets.

Please note that you will have to present your ticket at the gate.

All participants will be required to compete with an ASA license. Athletes can compete with a Permanent license or with a temporary license that will be available to purchase at the event for R70.00 per license.

Please note that only registered AGN/ASA coaches will be allowed to enter the stadium and only if their athletes are participating. Please bring your coaches card with you.
