CIRCULAR 99 OF 2025 – 2026 AGN TRACK & FIELD U16, U18, U20 AND SENIOR PROGRAMME

Dear AGN Members

The 2026 AGN Track & Field season for the U16, U18, U20 and Senior age groups will commence early next year with four League Meetings leading up to the compulsory AGN U16, U18, U20 and Senior Track & Field Championships, which will take place on 13 – 14 March 2026 at Pilditch Stadium.

The ASA Age Group Championships + U23 and Relays + Multi Events are scheduled to take place at Germiston Stadium from 26 – 28 March 2026, while the ASA Senior Track & Field National Championships and Multi Events + Relays will be hosted at Stellenbosch University from 17 – 18 April 2026.

The 2026 AGN Track & Field League 1 meeting will take place on Saturday, 17 January 2026, at Pilditch Athletics Stadium. This meeting is open to the U16, U18, U20 and Senior age groups. Masters and Para athletes are also welcome to participate.

- Your personal information will be captured by the in-store cashier on behalf of Webtickets.
- Once payment has been made, tickets will be issued by the PnP cashier on your till slip
- You will also receive an automatic confirmation via email and SMS with a link to access your tickets.

Please note that you will have to present your ticket at the gate.

All participants will be required to compete with an ASA license. Athletes can compete with a Permanent license or with a temporary license that will be available to purchase at the event for R70.00 per license.

Please note that only registered AGN/ASA coaches will be allowed to enter the stadium and only if their athletes are participating. Please bring your coaches card with you.
