

Nedbank Running Club – Terms & Conditions of Membership

By registering as a member of the **Nedbank Running Club (“NRC”)**, you agree to the following Terms & Conditions. These Terms apply to **all members nationally**, regardless of club or provincial affiliation.

1. Definitions

- **“NRC”** refers to the Nedbank Running Club, including its national body and affiliated structures.
 - **“Member”** refers to any individual who registers as a member of NRC.
 - **“Platform”** refers to the NRC website, membership portal, and associated digital systems.
 - **“POPIA”** refers to the Protection of Personal Information Act 4 of 2013.
 - **“ASA”** refers to Athletics South Africa.

2. Membership

- Membership is confirmed upon successful completion of the registration process.
 - By registering, you confirm that all information provided is **true, accurate, and complete**.
 - NRC reserves the right to suspend or terminate membership in accordance with these Terms & Conditions.
 - Members must obey and comply with their NRC constitution.

3. Club & Provincial Affiliation

- During registration, members select their **club and province**.
- Club and provincial affiliation is used for **administrative, reporting, and operational purposes only**.
- NRC may share relevant membership information with the selected club or provincial structure where required for affiliation, competition, or compliance purposes.

4. Membership Fees

- Membership fees (where applicable) are payable as specified during registration.
- Fees are **non-refundable**, unless required by law.
- NRC reserves the right to amend membership fees with reasonable notice.

5. Athletics South Africa (ASA) Affiliation who is affiliated to World Athletics

- NRC is affiliated to **Athletics South Africa (ASA)** through the relevant provincial athletics bodies.
- Membership of NRC may include **ASA affiliation**, subject to the applicable rules, timelines, and requirements set by ASA and the relevant provincial athletics association.
- Members participating in ASA-sanctioned events must comply with:
 - ASA rules and regulations
 - Provincial athletics body requirements
 - Event-specific entry criteria
- NRC is not responsible for disqualification, suspension, or penalties imposed by ASA or any affiliated body due to non-compliance by a member.

6. Code of Conduct

Members agree to:

- Conduct themselves in a respectful and sportsmanlike manner.
- Comply with NRC rules, club rules, ASA regulations, and event-specific requirements.
- Refrain from conduct that may bring NRC, its sponsors, or affiliated bodies into disrepute.
- Obey and stay inside their rights as stipulated in their NRC constitution.
- Always compete in the official NRC /NIKE competition and podium wear.

NRC reserves the right to take disciplinary action, including suspension or termination of membership.

7. Participation & Risk

- Participation in running, training, and events involves inherent risk.
- Members participate **at their own risk**.
- NRC, its officials, sponsors, partners, and affiliated bodies will not be liable for injury, loss, or damage except where required by law.

8. Communication

By registering, you consent to receive:

- Membership-related communications
- Club and event notifications
- Administrative and operational messages

You may opt out of marketing communications at any time.

9. Protection of Personal Information (POPIA)

9.1 Collection of Information

NRC collects personal information including, but not limited to:

- Full name
- Identification number or date of birth
- Contact details
- Emergency or medical information (where required)
- Club and provincial affiliation

9.2 Purpose of Collection

Personal information is collected to:

- Administer membership
- Facilitate ASA and event affiliation
- Communicate club-related information
- Comply with legal and regulatory requirements

9.3 Processing & Storage

- Personal information is processed lawfully and securely in accordance with POPIA.
- NRC implements reasonable safeguards to protect personal data.
- Information is retained only for as long as necessary or as required by law.

9.4 Sharing of Information

- Information may be shared with clubs, provincial structures, ASA, and service providers for legitimate operational purposes.
- NRC will not sell or unlawfully disclose personal information.

9.5 Member Rights

Members may:

- Request access to their personal information
 - Request correction or deletion of inaccurate data
 - Withdraw consent where legally permissible

10. Media & Image Consent

- NRC events may be photographed or recorded.
 - By participating, members consent to the use of such media for **club, promotional, and reporting purposes**, unless otherwise stated in writing.
 - All NRC members consent to the use of their photos in any newsletters ,articles ,media releases ,results and media articles or Television programmes.

11. Amendments

- NRC reserves the right to amend these Terms & Conditions at any time.
 - Updated Terms will be published on the NRC platform.
 - Continued membership constitutes acceptance of the amended Terms.

12. Termination

Membership may be terminated:

- By the member, upon written notice
- By NRC for breach of these Terms & Conditions

Termination does not entitle the member to any refund unless required by law.

13. Governing Law

These Terms & Conditions are governed by the laws of the **Republic of South Africa**.
