

FIM AFRICA GENERAL ASSEMBLY 2021 HELD ON THE 12 DECEMBER AT 12H00 VIA THE ZOOM ONLINE PLATFORM

1. <u>WELCOME</u>

 Following a discussion and suggestions by certain FMN's, the President undertook to discuss this further with Council at the next meeting, especially relating to the matter of reserves.
- c. **Approval** of Interim financials as of 30 September 2021 (Distributed prior to GA) The Interim Financials were **APPROVED**.
- d. <u>Approval of current External Auditors for 2021 Audit</u> The appointment of JZ & Co for the 2021 audit was <u>APPROVED.</u>

8. APPROVAL OF PROPOSED AMENDMENTS TO THE STATUTES

An in-depth discussion ensued regarding the proposals presented. Following an online vote, 75% of the FMN's voted in favour of Proposal 3 (Maximum of eight (8) years). It was **FURTHER AGREED** that Council would work on the correct wording and amend the Statutes accordingly. The Statutes would be distributed to the FMNs in the new year.

9. PROPOSALS FROM CONU MEMBERS (IF ANY)

The secretariat had not received any proposals from FMNS's by the deadline date. No FMNs raised any proposals for discussion during the meeting.
