

## **Moses Mabhida Stadium**

You've seen the impressive Moses Mabhida Stadium dominate the Durban skyline from afar, now get up close and personal as we take you into the heart of Durban's majestic stadium.

Explore the state-of-the-art changerooms where your sporting heroes regroup, and walk through the tunnels they've walked through. Step onto the pitch and imagine thousands of roaring fans around you or discover the suites where the rich and famous are entertained. And that's just a taste of the captivating, all-access stadium tour. All areas of the tour are wheelchair-friendly, and are carried out by professional and knowledgeable guides equipped with a whole host of fascinating facts.

## **Take your Durban experience to new heights with the SkyCar**

Your journey starts with a two-minute SkyCar ride up the

stadium arch, before you step onto the platform and take in the unparalleled 360° views of Durban and beyond. The SkyCar gives you the chance to discover Durban from a 106m-high vantage point. Look one way and take in the ocean views as far as the eye can see, look the other way and you'll see the city living for miles. Why not try to spot your neighbourhood if you're a local?

Mounted on an undercarriage, the SkyCar is a single cabin that runs up steel tracks on the northern arch of the stadium and is designed to roll down the arch under its own gravity – this enables it return to the lower station, even in the event of a power failure. For the best scenery for miles, this must-see attraction is a must-do for locals and tourists alike.

## **Conquer the Arch**

There are two ways to get to the top of the 106m high arch. There's the SkyCar ride for those who can't wait to reach the top, and then there's the Adventure Walk for those who are up for a bit of a workout...Take in the scenery as you make your way up the 500 steps. It's a leisurely 20-minute walk to the top, and of course, there's a breathtaking view and photo opportunity at every stop to catch your breath.

Seventy metres up, you'll come across the Big Swing platform where the brave leap into the stadium bowl. Got the guts? Think about it on your way up. And when you get to the top, you can savour the 360° Durban views knowing you really earned it. All Adventure Walkers are issued with safety equipment and, under the watchful eye of qualified instructors, a group of up to nine people at a time will be able to make their way to the top. For a comfortable walk, it's best to wear appropriate footwear (trainers or flat, closed shoes).

## **Big Rush Big Swing- take the leap-**

Are you brave enough to free fall 80m into the stadium bowl?

Then read on...

The Big Rush Big Swing has been officially named the world's tallest swing by the Guinness Book of Records since 14 May 2011. Not your average swing, the aptly named Big Swing allows you to take the thrilling leap swinging out into a massive 220m arc where you soar into the centre of the stadium.

Go on, take the leap.

## **People's Park**

You're always welcome

This truly is a space for everybody. As soon as you get stuck into what the People's Park has to offer, you'll soon realise that every inch was designed with everyone in mind.

Stretch your legs and let your hair down, because the People's Park was made for taking it easy with the family. Come on over to the People's Park Café for a morning coffee, an afternoon lunch, or a weekend picnic. Bring the kids and their bikes along, and watch them do their thing from the café deck. And once they've worked up an appetite, let them choose something yummy from the kid's menu. Got something a bit more energetic in mind? Perfect. Get that training kit on, because the park has all the space you need to get your body moving and your blood pumping.

With the impressive stadium looking over the park, the green rolling lawns, the trees and the fountains – it's these scenic surroundings that make it impossible to want to leave.

And because access to the park, the secure parking and wi-fi at the café is free, you can take your time, do your thing and make the most of the park for the people.

## **Umgeni River Bird Park**

The Umgeni River Bird Park was designed and built by Dr Alan Abrey. It is situated in an old quarry site which used to contain water and was visited by Alan as a young boy growing up in Durban. When looking for a bird park site, he remembered it as a perfect option. After a year of extensive land filling, landscaping and aviary construction, the Umgeni River Bird Park was

opened in April 1984 by the then mayor of Durban, Councillor Sybil Hotz. The park is situated in 3.5 hectares of lush tropical landscaping and houses an ever-increasing collection of more than 800 birds from 200 species. Some species are the only representatives of their kind in Africa whilst others are commonly kept as pets.

## **Durban Botanical Gardens**

The Durban Botanic Gardens was established to participate in the quest of Kew Gardens to establish a series of botanic gardens across the world which would assist in the introduction of economically valuable plants, and to supply plants to Kew that were new to science. The first garden was established in December 1849 by Dr Charles Johnston on the edge of the Berea Ridge next to the Umgeni River (near Quarry Road). He was in charge of the gardens for less than 1 year.

A Scot called Mark McKen then took his place and began to establish gardens of plants of economic value such as sugar cane, tea, coffee and pineapples. In 1851 the botanical gardens were relocated closer to town, to its present site. From 1853 to 1860 there were various curators, the most notable of which was Robert Plant, who died of malaria while collecting plants near Lake St. Lucia. McKen then returned in 1860 and was the curator for the next 12 years; until his death in 1872.[1]

A German by the name of William Keit arrived from Glasnevin in Ireland to take over the curatorship of the gardens, but economic depression in Natal, a drought, and the Anglo-Zulu War took its toll. Keit resigned in 1881 to become a nurseryman and was later Durban's first director of parks.

The grounds currently host various social gatherings such as local music bands and 'Victorian tea parties', as well as an indigenous plant fair in spring (September) each year. The fair is hosted by the Botanical Society of South Africa, and in 2009 and 2010 the Lepidopterists' Society of Africa was involved to promote the growing of indigenous butterfly food plants. The theme of the Fair for 2010 was taken from the UN's International Year of Biodiversity, and more than 750 species of plants indigenous to South Africa were available.



This year the theme for our conference is **“Transformational Leadership in the Public Sector”** and it is also a celebration of our 90th birthday, the road over the years was exciting and at some stages bumpy but we are grateful for this achievement as an Institute which has sustained itself despite some difficult circumstances. The President and Board of CIGFARO welcome you to this years Conference and you are also invited to celebrate CIGFARO’s birthday with us at the Mayoral Reception on Monday evening.

# Foreword by the CIGFARO President



CIGFARO also wants to extend its gratitude to the Host City for entertaining us and to the Mayor of eThekweni for his hospitality. CIGFARO also wants to thank Ntiyiso as the Platinum sponsor for their contribution to the success of this Conference.

The purpose of our Conference is to learn, share, transform and implement. Through the years since 1994 emphasis was placed on the political change in South Africa. This has led to the change in legislation and the transforming of standard operating procedures and systems. With this in mind it is clear that we have all the ingredients in place to operate effectively. We have money, people, systems and legislation in place but when we look at our Audit outcomes year on year there is a regression with regard to the outcomes. This is a reflection on us as public servants. During the last couple of years, more emphasis has been placed on consequence management and the technical and political issues facing government daily and how turnaround strategies can be implemented to improve not only the Audit outcomes but also sustain and extend service delivery. Further, government has been riddled with accusations of Fraud and Corruption and the theme is therefore most appropriate to highlight the importance of Transformational leadership.

During this past year the Chief Justice raised the issue of leadership in government and he indicated that what the country needs is "Ethical Leadership". We see the use of Social media becomes more prevalent by Presidents, Ministers, and other high profile people. It would therefore be prudent for organs of

state to adjust their communication channels to include a 24/7/365 approach and interventions to deal with this. Constituents become more organised and vocal on social media regarding matters that upset or are unacceptable to the community. Security systems on networks in certain areas may be outdated and the possibility and risks of hacking becomes more and more a reality. Organs of state need to take this seriously and start with a revised Y2K program to review all the security employed on their networks and systems.

The 4IR is upon us and it is also the opportunity to start exploring what is on offer from the exhibitors in the exhibition hall of the conference. The term "Bot" should be on everyone's lips. We are living in the era of making use of robots to perform certain tasks which normally would have been performed by a human. The sending of a bill to a customer does not need human intervention - the whole value chain thereof can be performed by a "Bot".

It is therefore hoped that when you attend the sessions in plenary and the breakaway sessions that you will participate where possible and focus on the knowledge of others which could be used in the daily execution of your tasks. There is a constant drive to improve quality of our conference sessions and we will welcome your input which can be given at the CIGFARO stand.

**Mxolisi Kaunda**

Mayor Kaunda has a rich socio-political activism background and was appointed the MEC for Transport, Community Safety and Liaison in 2016, a position he held until becoming eThekweni Mayor. He has served in various leadership roles in both the ANC Youth League (ANCYL) and provincial structures. Born in Inanda, north of Durban, Mayor Kaunda gained political consciousness early on and became politically active at the tender age of 15 becoming involved in student politics and youth political activism. Mayor Kaunda obtained his Diploma in Governance and Leadership from the University of South Africa and an Advanced Diploma in Advanced Governance and Public Leadership from the University of Witwatersrand.

He previously served as a ward 57 councillor from 2000 to 2006 and as a proportional representation councillor from 2006 to 2009. He has served on various council portfolios such as the Economic Development and Planning Sub-Committee and Market Adhoc Committee. He served as the ANCYL Provincial Secretary from 2004 to 2008 before serving as the organisations provincial chairperson until 2010. In 2012 he was elected to the ANC Provincial Executive Committee (ANC PEC) and was assigned the responsibility of serving in the Economic Transformation as well as Peace and Stability sub-committees.

When he was re-elected to the ANC PEC in 2018 he served as the Chairperson of the Economic Transformation Committee. In 2009 to 2014 he served as a member of the Provincial Legislature and was Chairperson of the Transport Portfolio Committee. During this time, he served on Finance, Community Safety and Liaison as well as the Co-Operative Governance and Traditional Affairs Committee as an alternate member. He is also the current Provincial Chairperson of the Men's Forum.



**Peet du Plessis**

Peet has 38 Years experience in Local Government – South Africa. He started his career in 1980 in the office of the Auditor General, he left the office of the AG in 1988. He was appointed as Accountant at Drakensberg Divisional Council. He held the positions of Deputy Director of Finance at Drakensberg District Municipality when he left after 7 years of service. He was appointed as Deputy Treasurer at Tzaneen Municipality in 1995 and later appointed as Treasurer/CFO, he left Tzaneen after 9 Years. He is currently Head Revenue Management Unit at eThekweni Metropolitan Municipality. He has served on the executive of the KZN Branch and was Vice President of CIGFARO, he served on the Institute Council and standing committees since 2004, he is a Fellow Member, has written several articles for the IMFO Journal and he holds two National Diplomas, and a Btech Degree in Municipal Finance. He is also the current President of CIGFARO.

Dr Nkosazana Clarice Dlamini Zuma was the Minister of Home Affairs of the Republic of South Africa from 11 May 2009 until Sept 2012. Prior to her appointment as Minister of Home Affairs, Dr Dlamini Zuma served as a Minister of Health from 1994 to 1999 and as Minister of Foreign Affairs of the Republic of South Africa from 17 June 1999 to 10 May 2009. In 2018 till 2019 Dr Dlamini Zuma served as the Minister in the Presidency and is currently the Minister of Cooperative Governance and Traditional Affairs.

Dlamini Zuma was elected by the African Union Commission as its chairperson on 15 July 2012, making her the first woman to lead the organisation (including its predecessor, the Organisation of African Unity). She was in office from 15 October 2012 until 30 January 2017.

On 13 September 2019, Dr Dlamini Zuma was inaugurated Chancellor of the University of Limpopo, a position she will hold for the next five years.



**Dr Krish Kumar**

Dr Krish Kumar has a doctorate in Public Administration, Bachelor of Commerce degree in Accounting, a master's in Administration, a Management Development (MDP) certificate, and has completed the Minimum Competency Training prescribed by National Treasury for CFO's. He has presented papers at various conferences and participated in study tours worldwide, including the USA, Canada, South America, UK, India, Far East, Australia, New Zealand, and throughout Africa.

On behalf of the World Bank has undertaken a study of the state of local government finances in Tanzania as part of the assessment of a loan application made by Tanzania. He has delivered several training courses to the C40 cities climate leadership group globally. He has 39 years local government experience and has been the Chief Financial Officer (CFO) of the Ethekewini Municipality (Durban, South Africa) since 1997 (22 years). He was a member of South African Local Government Association Finance Working Group, Chairperson of the Metro Chief Finance Officer's (CFO) Forum for the CIGFARO, a Commissioner on the Financial & Fiscal Commission (FFC), and member of the Accounting Standards Board for two terms each. He is also the Past President of the Institute of Municipal Finance Officers (CIGFARO), as well as a Fellow of the Institute. He is currently a C40 global board member.

## THE NEW PUBLIC AUDIT AMENDMENT ACT – HOW DOES IT AFFECT YOU?

The Public Audit Amendment Act (PAA) introduces the concept of a material irregularity (MI). A material irregularity means any fraud, theft or breach of a fiduciary duty or non-compliance with or contravention of the law that could result in a material loss, misuse or a loss of a material public resource or substantial harm to a public sector institution or the general public.

The introduction of a focus on material irregularity is so that other common errors or deficiencies are isolated and those activities putting the public purse at risk of a financial loss are identified and pursued.

In terms of the new amend to the PAA, the Auditor General (AG) may or can make the following recommendations:

- ❖ Refer a suspected MI to a public body with a mandate and powers that are suitable for the nature of the specific suspected material irregularity. Authorities with requisite investigative capacity and skills include the public protector, special investigations unit and the South African Police Service. The public body would deal with the matter within its own legal mandate and take appropriate action where necessary; or
- ❖ Make recommendations in the audit report on how an MI should be addressed within a stipulated period of time. If these recommendations have not been implemented by the stipulated date, the AG must take binding remedial action and if the MI involves a financial loss, issue a directive to the accounting officer or accounting authority to quantify and recover the loss from the responsible person; or
- ❖ If the Accounting Officer or Accounting Authority fails to implement the remedial action, including a directive to quantify and recover a financial loss, the AG must issue a certificate of debt in the name of the relevant accounting officer or accounting authority. It is the responsibility of the relevant executive authority such as a minister, a member of the executive council (MEC) or a municipal council to recover the loss from the accounting officer or authority.

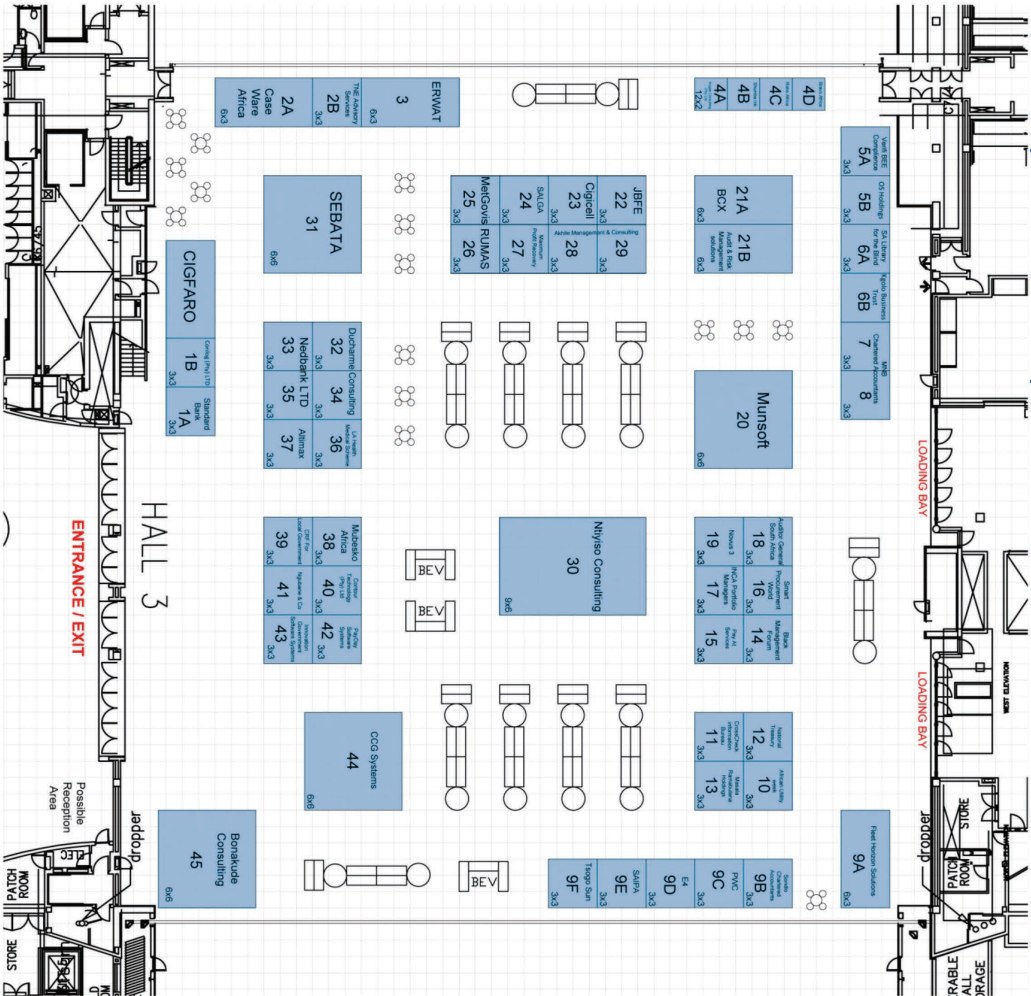
