

## MATERIAL IRREGULARITIES

The amendments to the Public Audit Act became effective on 1 April 2019. These amendments provide us with an expanded mandate to go beyond auditing and reporting in an effort to strengthen the accountability mechanisms across government, mainly through the material irregularity (MI) process.

### KEY SERVICE DELIVERY DEPARTMENTS

The audit outcomes of the key service delivery departments within the sectors of health, education, human settlements and public works lag behind those of other departments, indicating weaknesses in financial and performance management and compliance with legislation.

#### Local government finances continue to worsen:

- Over a quarter (26%) significant doubt on ability to continue as going concern
- Municipal debtors not recoverable (average 63%) resulting in creditors greater than available cash at year-end for almost half of municipalities (49%) and average creditor-payment period of 209 days
- Large portion (36%) of estimated recoverable revenue and equitable share used for salaries and council remuneration – only 2% of expenditure towards maintenance
- High unauthorised expenditure (R14 billion) and 30% ended year with a deficit

#### SOEs under business rescue or liquidation

- The South African Airways exited business rescue on 30 April 2021
- Mango (subsidiary of SAA) still under business rescue
- LMT products (subsidiary of Denel) out of business rescue and now sold. No longer a subsidiary.
- LMT Holdings, LMT engineering, LMT Properties, Denel Aerostructures (all subsidiaries of Denel) – under liquidation since June 2021
- South African Express Airways under provisional liquidation

#### Project deficiencies left unattended

- Inadequate needs assessment and project planning
- Ineffective monitoring of project milestones and contractors/ implementing agents
- Underperformance by contractors without consequences
- Contractors not paid on time
- Failure in intergovernmental coordination and collaboration




#### What we found again

- Delayed completion of projects
- Increased project cost and financial losses
- Quality defects
- Completed infrastructure not commissioned or not utilised

#### The impact remains

- Continued shortage of housing, good school infrastructure and access to health facilities
- Poor quality infrastructure shorter useful life and expose public to harm
- Money wasted could have been spent on other infrastructure priorities


