# Circular 78 of ASA 2017 (07/14) – 2018 ASA DOMESTIC RULES AND REGULATIONS, UPDATE

ASA Circular 62 has bearing.

ASA would like to thank ASA Members for positively responding before the due date of 12 July 2017 regarding recommendations to update the 2018 ASA Rules and Regulations for 2018.

ASA will be adding a chapter in the 2018 ASA Rules and Regulations to give guidance on the function and duties of Team Managements.

ASA will also be adding a chapter dealing with Ethics in Sport, and in doing so, align ASA with the IAAF Integrity Policy which were adopted by the IAAF Congress in 2017.

ASA also received many recommendations regarding clothing, particularly at club level. ASA will be revising ASA Rule 23 to align with IAAF Rules and Regulations. Please refer to the IAAF Advertising Regulations. A copy of the IAAF Advertising Regulations are attached to this circular and is also available on the ASA Website <a href="http://www.athletics.org.za/Technical">http://www.athletics.org.za/Technical</a>.

The amendment of ASA Rule 23 became a pressing matter, as South African Athletes are frequently performing well internationally. At these international events, there are large incentives involved, and wearing the wrong clothing during international events can lead to disqualification.

With the upcoming 2017 Cape Town Marathon, and with the event receiving gold status from the IAAF, it became important to guide athletes who want to participate in the 2017 Cape Town Marathon, as to how their running gear should be branded.

The final draft for the 2018 Competition Rules and Regulations will be ready soon and members can expect the final draft for proofreading early August 2017.
